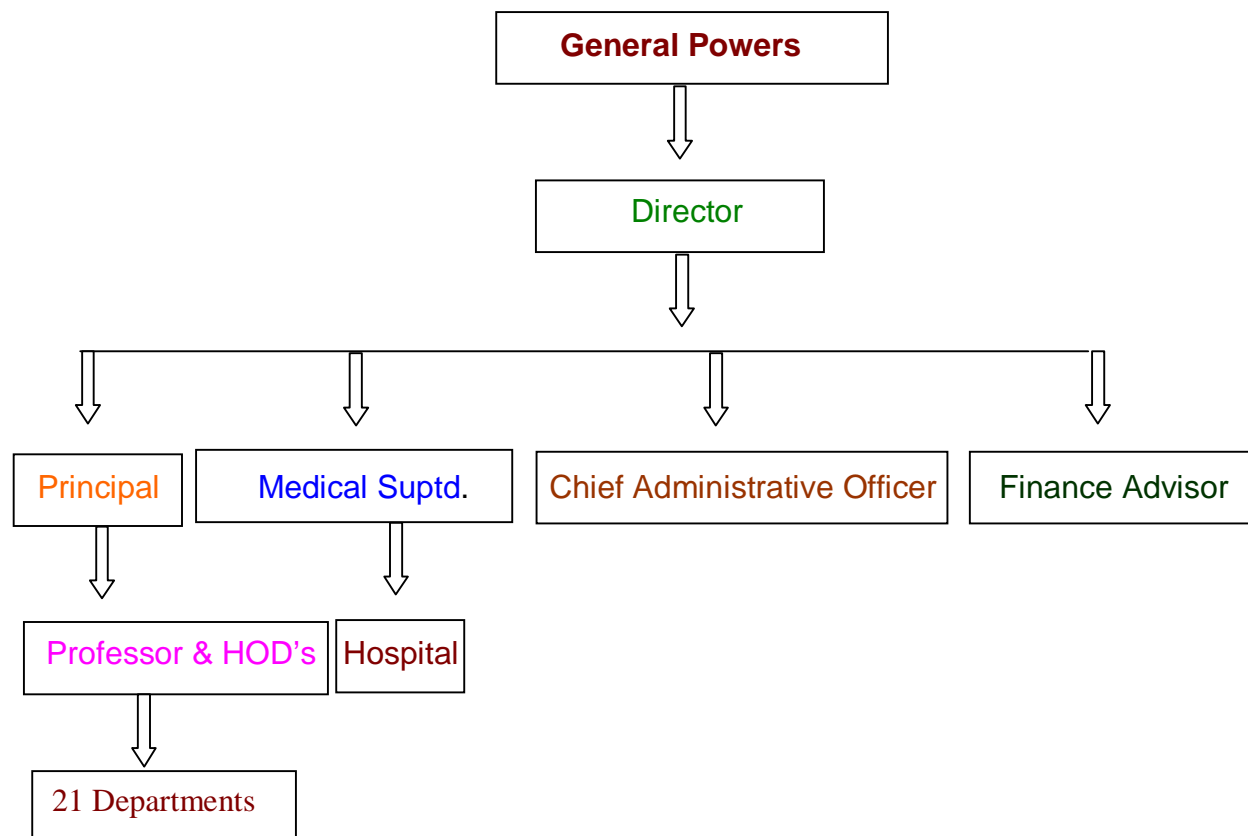

Decision making

Decision making process, the files are originated subject wise in respective departments verified and recommended to the Director, who decides and disposes the cases finally as per rules, Bye – Law and other norms.

Certain proposals are submitted to the government and permission is obtained from the government for important matters. All subject are decided finally in the Governing Council. In respect of financial matters the proposals are submitted to the in finance committee and decisions are taken.

Functions of the RIMS

The Director who is head of the organization is empowered with all the powers and responsibilities for the smooth management of the institution. Working hours of the administrative office is as follows.

The academic classes are conducted including practical classes in between 9.00 am to 4.00 pm.

There are 21 departments in this organization. Each department is headed by Medical professional of the Rank of the Professor. Assoc. Professor, Asst. Professor, Tutors & Residents are working under the control of each HOD's. All these members of faculty are working as per the Bye – Law of the institution, government rules and directives of the MCI.

The powers of the Director are fully vested with academic, administrative, Medical & Finance, under the control of Governing Council. The respective HOD are under the control of Director. HOD's of the each Departments are responsible for the administrative and academic affairs of respective Departments.

There are many committees for administrative, academics and other affairs as per Bye – Law. All these committees are to function under the instructions & norms of Government, RGUHS, MCI & Bye Law of the institution.
